Mr. HUANG Guoyong

Mr. Huang Guoyong is Director of International Cooperation and Development Department (Free Trade Zone Arbitration Department) of the Shenzhen Court of International Arbitration (SCIA) and Secretary General of the South China International Arbitration Center (Hong Kong) (SCIAHK)

Mr. Huang Guoyong has more than ten years of working experience in financial institutions and government departments. He has extensive experience in dispute resolution, specializing in the fields of international trade, finance and capital markets. He joined the Shenzhen Court of International Arbitration (also known as the South China International Economic and Trade Arbitration Commission and Greater Bay Area International Economic and Trade Arbitration Commission, hereinafter the “SCIA”) in 2017, and currently serves as Director of the International Cooperation and Development Department, taking charge of administration of foreign-related arbitration cases, communications between legal & business communities, international cooperation, as well as collaboration among the Guangdong-Hong Kong-Macao Greater Bay Area. Mr. Huang also provides support and guidance for the operation of specialized platforms such as the SCIA Mediation Center, and GBA Arbitration & Mediation Alliance, etc. In 2022, Mr. Huang was appointed as Secretary-General of the South China International Arbitration Center (Hong Kong) (SCIAHK), providing support and guidance to its daily operations.
